



Dear User!

Hereby we would like to inform you that the General Terms and Conditions for the Use of Car Sharing Services (hereinafter: GTC) is changing as of 21 June 2018.

In the frame of these changes the following points of the GTC will be changed: point 1.6, 3.6, 4.12, 7.1.2, 7.1.4, 7.1.33, 7.2.1, 7.2.11 D), 7.3.2, 7.3.3, 8.2, 9, 10.2.14, 10.2.15, 10.2.16 and Annex 1 and 4.

The changes are summarised as follows:

- 1.6: Availability of the business partner code of ethics of the Service Provider.
- 3.6: For the request of the User the Service Provider provides the GTC to the User on durable medium or via e-mail or in paper form without any additional cost.
- 4.12: Clarification regarding the fact that the contracting language is the Hungarian.
- 7.1.2: It is added to this point that if the User books the same passenger car twice after another, but does not open the passenger car at any of these occasions with the APP, then the User may not book the same passenger car for 120 minutes following the second booking.
- 7.1.4: It is added to this point that the passenger cars may only be used in the territory of Hungary.
- 7.1.33: Clarification of the rules regarding stopover. The starting time of the stopover is when You have closed the passenger car with the key after stopping the engine of the car with the ignition key, and the end time is the time when You have started again the engine of the car.
- 7.2.1: Using of other persons debit/credit card. You should have the written consent of the owner of the debit/credit card!
- 7.2.11 D) and Annex 4.: Terminological clarifications
- 7.3.2 and 7.2.11 D): Clarification of the parking rules. We would like to draw your kind attention again to the fact that You may only park the passenger car in public areas, the journey may not be ended and the passenger car may not be left in a private parking place (e.g.: in parking house), even if the parking house would be for free of charge. Any fees deriving from this shall be paid by You!
- 7.3.3.: Should You see that the range of the passenger car may go with the further usage under 20 kilometre, You shall duly park and lock the passenger car. Please therefore pay always careful attention to the dashboard screen! Breaching this rule is considered as serious breach of contract, and in addition, in case You may lock the passenger car with the range under 10 kilometre left, You shall pay an additional 10 000 HUF penalty!
- 8.2: Inserting reference to the Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation, GDPR).
- 9.: Instead of working days, the deadline will be counted in days regarding the delivery of e-mail messages.
- 10.2.3: Underlining the rule that when using the Service You shall be in proper condition for driving and at the time of using the Service You possess a valid driving license.
- 10.2.14. and Annex 4.: Please, always use the passenger car lawfully, with respect of the traffic rules! Should any fine, fee, additional fee or other cost arise or the transportation of the car would be necessary due to Your usage of the passenger car, then in addition to the fines, fees and transportation cost we impose a process fee as well, which now will be increased to HUF 10 000. MOL LIMO will charge You with the amount of fines after receipt of the relevant document requesting the payment.  
The fee of lost ignition key is increased to HUF 100 000 HUF, and the cleaning fee to HUF 10 000.
- 10.2.15, 10.2.16: Correction of numbering of the points.

Please be informed as well that Annex 1 of the GTC, the Privacy Policy is changing as well now as follows:

- The Privacy Policy has been reviewed according to the rules of the GDPR.

- Rules regarding the handling of GPS coordinates (geolocation data) generated during the User's Individual Rental Agreement due to the movements of the passenger car.
- Your rights concerning data processing and their limitations according to GDPR.

Should You not wish to further use the Service, You are entitled to request the deletion of Your User Account and thus terminate without the need for justification the Framework Agreement concluded for the usage of the Service.
