

Dear User!

Hereby we would like to inform you that the General Terms and Conditions for the Use of Car Sharing Services (hereinafter: GTC) is changing as of **5th November 2019**.

In the frame of these changes the following points of the GTC will be changed: 3.1, 4.1, 7.1.4, 7.1.14, 7.2.2.1, 7.2.11, 7.3.3, 7.5.9, 10.2.8, 14. and Annex 3.

The GTC amended according to the above can be found from **4th November 2019** on the website of MOL Limitless Mobility Kft. under the following link: <https://www.mollimo.hu/hu/legal>.

The changes are summarised as follows:

- The „Application” term in the application has been modified in several points of these GTC.
- 3.1: This point of the GTC has been modified with the Business Clients and their Business Users.
- 4.1: The establishment of the Framework Agreement and the Individual Rental Agreement has been specified.
- 7.1.4: The Users shall return the passenger cars to the LIMO zone by the end of the rental, but at the least before the maximum duration of the Individual Rental Agreement (24 hours).
- 7.1.14: This point of the GTC has been modified. The User shall provide the necessary technical equipment for the transport of the child.
- 7.2.2.1: The Monthly Plan shall be valid from the day of choosing it starting from the minute of choosing until an indefinite duration. Payment of the monthly fee is primarily possible with the registered credit/debit card of the User.
- 7.2.11: Fees arising out of use not in conformity with the contract is deducted from the bankcard registered by the User, to which the User agrees by accepting these GTC.
- 7.3.3: User shall duly park and lock the passenger car in the LIMO Zone if the User sees that the range of the passenger car (to be seen on the dashboard display of the car) may go within 10 and 20 kilometre.
- 7.5.9: The Service Provider shall not be held liable if the User claims to have missed the flight due to using the Service.
- 10.2.8: Users may not transfer their User Account or the rented passenger car to any third party, and may not allow third parties to use the passenger car rented. The passenger car may be driven solely by the User who concluded the Individual Rental Agreement. Users shall be liable for all damage arising out of transfers their User Account or the rented passenger car to unauthorised persons, and shall be liable for paying the fee defined in Annex 3..
- 14: A new point has been added to the GTC, which contains special Terms and Conditions for Corporate Customers and Business Users.
- Annex 2 has been removed, so the Annexes have been modified according to this new order.
- Annex 3: There has been a few changes in the Rates. The Stopover fee, the Process fee and the Cleaning fee has been modified.

Please be informed as well that Annex 1 of the GTC, the Privacy Policy is **changing** in frame of this GTC change.

MOL LIMO publishes information on MOL LIMO's Facebook page, on www.mollimo.hu website and also in LIMO Newsletter. MOL Limo sends information via e-mail to Users who are subscribed to the newsletter about the current discounts and promotions, also MOL Limo publishes information about the current discounts, offers on their existing social media channels. The Users can subscribe to the newsletter in the application.

Should You further use the Service following the coming into effect of the GTC, this will be considered as Your acceptance of the GTC with the amended rules.

Should You not wish to further use the Service, You are entitled to request the deletion of Your User Account and thus terminate without the need for justification the Framework Agreement concluded for the usage of the Service. The Framework Agreement shall terminate with the deletion of Your User
