

Dear Limo-User,

Hereby we would like to inform you that the General Terms and Contract for the Use of Car Sharing Service (hereinafter: GTC) is changing as of 2nd November 2022. In the frame of this change, points 2., 3., 4., 5., 7. and 11. and Annex 1., 2. and 3. of the GTC will be changed. With the changes we have also updated the MOL Limo Privacy Policy.

The hourly rates have been introduced

We have introduced a new pricing category next to the minute fee and the longterm rental. With hourly packages, you can use our cars for every hour after the first full hour at a reduced rate compared to the minute-based rental, until the daily fee is reached.

2-, 3-, 4- and 5-hour packages do not need to be pre-selected, the system will automatically calculate the rental rates according to the most favourable pricing package for the user.

Hungarian address card to be provided during new registrations

The registration process will also require the Hungarian address card. The MOL Limo Privacy Policy has been updated accordingly.

Three car types had been phased out

Until the end of October, the Smart Fortwo, Forfour and VW e-Up models were phased out from the fleet. In line with this change, we have updated the relevant points of the GTC and Annex 3 on the Tariff.

Few changes has been introduced regarding the Tariffs.

- 2, 3, 4 and 5-hour packages introduced
- monthly subscription with 20% discount: HUF 1.490
- Airport zone: HUF 2.490
- Cleaning fee: HUF 30.000

Limo has joined to the MOL Move loyalty program

From October, those with MOL Limo registration can also join the MOL Move loyalty program, and by linking the two user accounts can collect points and extra discounts.

Other changes

- Clarification regarding the List of Contract Breaker Users
- Forfeiture of the right of withdrawal according to the Decree 45/2014 (26.II.) has been clarified as set out in the Decree.

MOL Limo Privacy Policy has been changed

The Privacy Policy has been amended to include the List of Contract Breaker Users and the data handling related to the address card.

Should You further use the Service following the GTC change, this will be considered as Your acceptance of the GTC with the amended rules.

Should You not wish to further use the Service, You are entitled to request the deletion of Your User Account and thus terminate without the need for justification the Framework Agreement concluded for the usage of the Service. The Framework Agreement shall terminate with the deletion of Your User Account. The termination request may be sent via e-mail, or via post with registered mail to the following address:
